It is very important that you complete the consultation survey regarding significant proposed changes to the school catchment area.

Carmarthenshire County Council is proposing that Peniel should lose the Bronwydd and Dolgwili catchment area, which is home to approximately 12% of the school's population. In its place, it would adopt an area within Brechfa Forest that has no population. This would have a detrimental impact on the school.
